Of the 15 current NCDO members, 9 have Men's and Ladies' Teams, 4 have Men's Teams and 2 have Ladies' Teams.

Additional Important Notes:

Matches start at 2:00 p.m. and must be played on at least 3 boards (more boards can be used if available).

See NCLC Rules regarding rescheduled matches.

A player must play in at least half of her team's matches to qualify for tournament play.

That minimum this year is 4 matches for NCLC East Division teams and 3 for the NCLC West Division teams.

As per league rules, forfeits this season will carry a score equal to last season's average winning total. Therefore, NCLC forfeits will be scored 17-0.
